Membership Benefits

No less than 120 (One Hundred Twenty) available track days per year, which will run rain or shine. Access to Club lounge, private showers and bathrooms for members and their guests.

Corporate Member will be granted photo membership identifications, and access card/keys to allow access to and member-only facilities.

Track sessions will typically run between 9:00 a.m. and 5:00 p.m., and may run in 3 groups: track-prepared cars, race-prepared cars, and sports racers/formula cars. Number of groups each day may increase or decrease depending on the number and type of cars in attendance each day. There will be a 30-minute break for lunch each day for all safety workers.

Corporate Members will be granted twenty one-day driving guest passes annually. Additional guest passes may be purchased in advance. All guests must have the similar track experience to Member and be submitted for approval prior to attending any lapping day. **No more than two driving guests and five non-driving guests are permitted on any single day. Any single driving guest may come twice in their lifetime. Instructors and coaches other than those from The Club will be excepted from this rule but will count against the driving guest pass allocation.**

In addition, Corporate Members will receive one day per season as a private corporate entertainment event. They may bring out sponsors, employees, clients- anyone they want to thank for a good year. Full access to the track and clubhouse will be granted, and all services, including corner workers, EMTs, wrecker, and liability and excess medical insurance are included.

Membership Requirements

Members must notify Putnam Park a minimum of a day in advance of the Club scheduled days they would like to run. Members must register the morning of each lapping day, and given wristband, which must be clearly displayed each time prior to entry on to the track. It is the responsibility for members to have their vehicles professionally inspected prior to each lapping day. Only approved vehicles may be driven on the track. SUVs and trucks are not permitted in the club. Management reserves the right to refuse a vehicle for any reason.

Members agree to adhere to the rules and regulations in the Member Manual that will be issued upon acceptance of the Membership Application. Membership may be revoked without refund by management if annual dues are not paid by deadline, any crime is committed by a member or guest on the property, or for infraction of any rule or regulation in the Member Manual.

Members are encouraged to have annual physical examinations by a physician prior to driving in any Club event.

Membership Limitation

Membership may not be transferred. Dues are subject to increase.
