**Membership Benefits**

No less than 120 (One Hundred Twenty) available track days per year, which will run rain or shine. Access to Clubhouse, private showers and bathrooms for members and their guests during Club Member days (from opening until Midnight) as well as weekend events until regular gate closing time, with one guest allowed on non-Club days. Member will be granted access card/key to allow access to member-only facilities and wrist band upon arrival for each Member day. Track sessions will typically run between 9:00 a.m. and 5:00 p.m., and run in 3 groups: street cars, race-prepared cars, and sports racers/formula cars. Number of groups each day may increase or decrease depending on the number and type of cars in attendance each day. There may be a 30-minute break for lunch each day for all safety workers, if corner workers are on station. Members will be granted 10 one-day driving guest passes annually. Additional guest passes may be purchased in advance. All guests must have the similar track experience to Member and be submitted for approval prior to attending any lapping day. Founding Level members will be granted preferred garage reservations on the Club member lapping days that they attend as well as permanent liquor lockers behind the bar and lockers in locker room.

**Membership Requirements**

Members must notify Putnam Park a minimum of a day in advance of the Club scheduled days they would like to run. Members must register the morning of each lapping day, and given wristband, which must be clearly displayed each time prior to entry on to the track. It is the responsibility for members to have their vehicles professionally inspected prior to each lapping day. Only approved vehicles may be driven on the track. SUVs and trucks are not permitted in the club. Management reserves the right to refuse a vehicle for any reason.

Members agree to adhere to the rules and regulations in the Member Manual that will be issued upon acceptance of the Membership Application. Membership may be revoked without refund by management if annual dues are not paid by due date, any crime is committed by a member or guest on the property, or for infraction of any rule or regulation in the Member Manual.

Members are encouraged to have annual physical examinations by a physician prior to driving in any Club event.

**Membership Limitation**

Membership may be transferred subject to Putnam Park approval. Putnam Park will retain 20% of the proceeds or \$6,000.00 (whichever is greater) as a transfer fee. If Member decides to leave Club any time after three years and does not sell membership, it may be turned in for a refund of 50% of Membership fees (not including annual dues), provided dues are up to date and there have been no infractions of the Membership Requirements or rules. Dues are subject to increase. **Membership will be terminated and all Membership fees forfeited if Membership fees and annual dues not paid by due date each year.**

**FINAL PAYMENT OF MEMBERSHIP FEES:** 1/3 MEMBERSHIP FEE (\$11,666.66) PLUS 3<sup>RD</sup> YEAR'S ANNUAL DUES. DUE ON 2<sup>ND</sup> ANNIVERSARY OF APPLICATION DATE.
